2022 PMEA Annual Conference Registration Policies

- 1. PMEA Conference Attendees are required to show proof of full vaccination during the time of registration. Masking will also be required. Please see the Annual In-Service Conference page of the PMEA website (https://www.pmea.net/pmea-annual-in-service-conference/) for information regarding the process of requesting a medical or religious exemption.
- 2. There are three registration time periods: 1) **Early** until March 1; 2) **Regular** until March 30; 2) **On-Site** March 31 April 9. Registrations postmarked after **March 30** will not be processed but will be taken to the conference site and the on-site fee will be assessed.
- 3. Refunds of registration fees will be returned until the conference opens if your school district attendance request is denied. A letter must be submitted for a refund **before** the regular registration deadline of **March 30, 2022**.
- 4. Following the conference, refunds for illness or emergencies will be given upon submission of written request and supporting documentation (physician's statement, emergency information, etc.). Refunds are subject to a \$15 processing fee. All refunds must be submitted in writing to the PMEA Executive Office by Monday April 25, 2022.
- 5. Membership must be current at the time of registration. Expiration dates prior to June 30, 2022 are not acceptable; registration will be processed at the non-member rate and you will be invoiced for the difference.
- 6. If you are not currently a member and wish to join, the membership application can be found by scrolling over the Membership menu option and selecting the "PMEA Membership Information" link on the PMEA website at www.pmea.net. Please send the completed application along with your conference registration form to PMEA.
- 7. A check or credit card information must accompany the conference registration form. We cannot accept purchase orders. PMEA accepts all major credit cards. If your check is returned for non-sufficient funds, you expressly authorize your account to be electronically debited or bank drafted for the amount of the check plus applicable fees.
- 8. Online registration is available for those wishing to pay with a credit card. To do so, log in to the PMEA website at www.pmea.net using your email address as your username and the password you created. Once logged in, select the PMEA Conference Information link from the "Conferences and Events" menu option. You will find the conference registration link on this page. You must be logged in to receive the member registration rate.

- 10. The family member registration rate includes one spouse and up to four children under the age of 12. The JHS/HS Student rate is a per person rate. Please use the back of the registration form if you need to add names for badges.
- 11. The daily fee is for PMEA members who plan to attend only <u>one day</u> of the conference. <u>Do not pay the daily fee if you plan to attend more than one day</u>. The daily fee is available for Thursday, Friday or Saturday (please note there are no exhibit hours on Saturday). <u>Nonmembers may not register at the daily rate</u>.
- 12. <u>All-State concert tickets may be purchased online at ticketor.com/pmea.</u> All concert tickets are non-refundable. Tickets for the 2022 All-State Festival Concerts are \$15 each. The All-State Chorus will perform Friday, April 8 at 3 p.m. at the Kalahari Convention Center (Kilimanjaro Ballroom). The All-State Jazz (vocal and instrumental) ensembles will perform Friday, April 8 at 4:30 p.m. at Pocono Mountain West HS. The Saturday schedule is as follows: All-State Concert Orchestra 11 a.m.; All-State Wind Ensemble & Band 2 p.m.; The Saturday concerts will be held at the Kalahari Convention Center (Kilimanjaro Ballroom). Seating for ALL concerts is General Admission.
